CHAPTER I

INTRODUCTION

A. Background of Study

In the 21st era, students who initially do not understand using technology in collaboration with the field of science are very difficult to find the right way to learn effectively and efficiently, especially in the field of information, communication, and technology (ICT). In the era of increasingly sophisticated development of science and technology, many changes have occurred in learning English, especially speaking skills.

In general, it is very important to improve the students speaking skills. The researcher finds that many students of Madrasah Aliyah Mathlaul Anwar Pusat Menes understand English language, but they cannot speak it well. The development of content using podcasts as media strongly influence students' speaking ability, especially in conversation. To develop students' speaking skills, nowadays it is necessary to master the basics of speaking skills.

Students frequently use mobile technology in their life, and some of these technologies offer good opportunities significantly to extend the time and place of study. One of them is podcast media.¹ In the educational environment, podcasts are a new form of radio broadcasting, which presents more creative material. The difference between podcasts and radio broadcasts lies in the way they are presented, among others, podcasts can be recorded and edited, while radio broadcasts must be connected directly.

The researcher also wants to prove that developing material for speaking using podcasts and the final product is youtube content can be an alternative way to learning speaking skills in Madrasah Aliyah Mathlaul Anwar Pusat Menes. *Third*, to know how to teach speaking skills using podcasts. In addition, The researcher saw that some students had difficulties in practicing speaking skills and the researcher saw this phenomenon as a trigger for gaps in language acquisition, especially English.

Because of difficulties in practicing the speaking skill in daily activities, students tend to find it difficult to apply learning outcomes in class. This study intends to help train students' speaking skills to develop and be confident in showing their abilities. Therefore, the researcher argues that podcasts can be a medium that can be used to fix this gap.

This research can be a very useful learning media innovation to help students practice effectively. This research has a goal in the use of technology and communication in the scope of language learning, especially English.

B. Identification of Problem

Based on the background of the study, the researcher has identified that students' needs are how to learn effectively and efficiently practices speaking skill. The researcher identified that in the 11th Grade of science class (XI IPA 2) of Madrasah Aliyah Mathlaul Anwar Pusat, students often misunderstood the application speaking in conversation, and the researcher have to design the current product.

C. Statements of Problem

- How effectiveness students speaking skill using podcast in XI IPA 2 Madrasah Aliyah Mathlaul Anwar Pusat Menes?

D. Scope of Problem

To limit the scope so that this research can be controlled, the researcher will focus on the designing product and effectiveness of the use of materials and media. In this study, the researcher will make the product in the form of learning media, especially using podcasts and publications on the youtube platform. The researcher will only focus on making the content of learning media products so that they can be used properly.

The researcher found several previous studies that discussed the same topic, including *First*, The topic is "The Use of Podcast in Learning Pronunciation in Class VII SMP NEGERI 10 Wedi Klaten" by Francissca Kristanty Bijak Ampuni, Sanata Dharma University, Yogyakarta, 2017. This study discusses the use of podcasts to help students at SMP Negeri 10 Wedi Klaten Yogyakarta. The researcher used Classroom Action Research (CAR) to conduct this research. The researcher used a pre-test, post-test, flashcards, podcasts, questionnaire, and students' assessments based on pronunciation rubrics.² The difference in this study lies in the method used, the research compiled by the researcher uses the R&D method, while the above study uses CAR in data collection. Second, "The Effect of Using Podcast on Students" Speaking Skill at The Second Grade of Students Junior Highschool" by Putri Purnama Sari from Islamic State University Sulthan Thaha Saifuddin, Jambi, 2019. The title of this study uses quantitative methods to obtain data. The data presented in this study is a quasi-experimental research design. Data collection techniques taken in this study were pretest and post-test to obtain data.³ In the research presented by the researcher, of course, the output is different. The researcher is a product in the form of teaching materials developed to improve the speaking skills of students of Madrasah Aliyah Mathlaul Anwar Pusat Menes with podcasts. Third," The Correlation Between EFL Learners' Speaking Competency and The Use of Podcasts" by Herning Budiastono, University of Panca Sakti, Vol.1, No.3. Juli 2021.
