CHAPTER 1 INTRODUCTION

A. Background of Study

Now, communication using English between humans is needed for many factors such as in business, marketing, education, and even for da'wah as well as humans communicating with each other by language. Public speaking refers to a type of communication addressed to a large number of people and usually in the form of a lecture or speech. It proposes to convey information, influence, or entertain the audience. Dakwah is basically nothing special, it should have become common place, moreover it is only conveyed to people who only know but is conveyed to answer problems in society. So a strategy is made that can be reached by all levels of society. Etymologically, the word public comes from English which means "the general public" while speaking is speaking or giving a speech.¹ In its long history, the term public speaking is better known as rhetoric or in English rhetoric comes from the Greek rhet which means a skilled and agile person in speaking. The notion of developing rhetoric includes skills in generating ideas, views, opinions, fluency in speaking, skill in influencing people with words, creativity and improvisation.

Emm Griffin explains as Aristotle that rhetoric is a person's ability in every fact that is used to influence. Rhetoric is often used to make decisions in arguments, legislative debates, political meetings, religious sermons and speeches at special celebrations.² Jason S. Wrenc explained that public speaking is the process of designing and sending a message to an audience. Effective public speaking is involving yourself with understanding the audience and the purpose of the conversation, choosing basic topics according to the audience's background and being able to send messages skillfully³.

It can be concluded that public speaking is a form of oral communication in the form of presentations, lectures, speeches or other types of public speaking to convey an idea, ideas, thoughts and feelings in a coherent, systematic and logical manner with the aim of providing information, influencing and even entertaining the audience. As with other forms of communication, public speaking also has several basic elements with the communication model proposed by Laswell, namely speakers, messages, listeners or audiences, mediums and effects.

Integrating a public speaking system that focuses on lectures or da'wah with language is not an easy thing, there must be a teacher's role and a place to study. Pesantren is a boarding school as a moral fortress. It takes moral example to create words that can make listeners comfortable and of course the implicit message will be easily conveyed which of course will not make the listener offended by what is conveyed. Not infrequently many people forget the importance of maintaining behavior by violating norms such as speaking harshly that is not in accordance with the rules of speech, and all of this makes character education very important when the value system collapses, including ethics and morality due to changes in a world without filtering.⁴ One of the most important aspects in the success of da'wah a dai is a skill or ability to speak which this ability can be obtained from knowledge of public speaking. Public speaking and da'wah activities have the same goal, namely giving information, inviting to good things.⁵

Boarding school is an Islamic educational institution as a place to convey knowledge. Islamic boarding school also have a very big role in terms of language, including English which has 4 important skills, namely: Speaking, Reading, Writing, and Listening. However, in general, the skill

most widely used in Islamic boarding school is speaking, especially in Arabic. Not only training these skills, Islamic boarding schools are also the future choice for developing the potential of students and the forerunners of world civilization. The Islamic education system needs to be formulated in accordance with the times so that it is able to produce scholars according to their needs and become a pillar of change in the misguided world civilization.⁶ Lectures can change situations and conditions that are not in accordance with Islamic teachings,into situations and conditions that are in accordance with Islamic teachings.⁷

At the Al Madina Islamic boarding school, it is one of the destinations for research on public speaking strategies that lead to da'wah. Because the form of activity implemented in the boarding school is produced by a linguistic institution called CLI (Central language improvement). In its activities to improve public speaking skills, the institution combines speech strategies with religious elements. Which in the content or text, the speaker includes several hadiths or the Qur'anic verses to justify the words delivered on a particular theme. The importance and obligation of da'wah lies in the

universal nature of Islam.⁸ In addition to the application of public speaking in CLI, there are also many activities that can have a good influence on students' linguistic fields, for example from the vocab reading activity which is carried out every morning, grammar structuring learning which is often called the English Corner where every activity takes place the members are required to produce a work in the form of an essay such as short story even an information. Not only deepening grammar from a writing point of view, there is one more activity that might have a good influence on CLI members, namely the activity of opening a dictionary, Oxford or John M. echols. This CLI Club is specifically for members who are diligent in using the language in the Islamic boarding school environment, but if students have more desires, of course the CLI management will also provide opportunities for these students.

During the teaching and learning process at Islamic boarding school, speaking skills are also developed with various forms of activities that can make students more interested in speaking, especially in the form of language, students must get the opportunity to practice speaking English. This is an opportunity for students to communicate with other people, especially in the public speaking program while at the same time conveying the knowledge they have learned. from the public speaking program which

of course is held with courses that provide opportunities for members to learn English with a focus on 4 things namely speaking, vocabulary, grammar, and pronunciation. In this case, the researcher designed an analysis of public speaking strategies as a way of Da'wah at the Al-Madinah Islamic Boarding School. In Islamic boarding schools there is a course called CLI (Central Language Improvement) in the management of language departments, one of which is public speaking. Even though the Boarding school has only been established for two decades, this Boarding school has a public speaking strategy as a way of Da'wah. This can be seen from the form of activities carried out at the Al-Madinah Islamic Boarding School, and the management involved in these activities so that they can succeed in the activities.
