CHAPTER V

CONCLUSION AND SUGGESTION

In this chapter, the researcher presents the conclusions and suggestions in the last part of this writing. The conclusions are drawn based on the research problems formulated in the first chapter and the findings in the fourth chapter, while the suggestions are intended to give information to the next researchers who are interested in doing future research in this area.

A. Conclusion

This study examines the syntactic structures formed in the translation of Surah Al Jumu'ah translated by Abdullah Yusuf Ali. Based on the findings in Chapter IV, the writer found that there are seven phrase structure patterns occur in the Abdullah Yusuf Ali's translation of Surah Al Jumu'ah. Those phrase structure patterns are classified into (1) the pattern of S, (2) the pattern of VP, (3) the pattern of NP, (4) the pattern of PP, (5) the

pattern of ADJP, (6) the pattern of ADVP and (7) the pattern of CP.
