CHAPTER I

INTRODUCTION

A. Background of The Study

English language is an essential communication tool for human life, English language use as international language. Therefore, we have to able to master the language and its elements such as vocabulary, structure, and so forth. The language itself consists of two asfects namely form and meaning. In relation to meaning, the smallest meaningful in language is morpheme.

Morphemes in morphology are the smallest units carry meaning or fulfill some grammatical function. The word 'house' consist of one morpheme, and because it stand by self it can be called a *free morpheme*. In the word 'houses' there are two morphemes, 'house' is free and 's' is a *bound morhpem*'. Nida give a simpler definition of morphology cited Ilzamudin Ma'mur and As'ari B. Fathoni, he state that "morphology is the study of morphemes and their arangements in forming words". There is similar situation with bound morphemes which are subdivided into derivational and inflectional morpheme.² Morphologists usually talk in quite different terms about inflection and derivation.³

Derivational morphemes are those morphemes which produce new wrods, or changen the function of a word, it achieved by means prefixes or suffixes in case ofe English.⁴ According to Nic Cipollene, Steven Hartman Keiser and Shravan Vasishth "in English the Derivational morphemes are either prefixes and suffixes.⁵ Then, they said characteristics of the derivational, following below:⁶ Change the part of speech or the meaning of a word, e.g., -ment added to a verb forms a noun judg—ment, and re-active means 'active again'.

For example, the word "following" in the article Youtube Kids Wants to Help Preserve Indonesian Folktales of The Jakarta Post is a process derivational, from verb (follow) to noun (following).

Inflectional morphemes do not create new word, but only show grammatical funtions of a word.⁷ According to Nick Cipollone, Steven Hartman Keiser and Shravan about characteristics of the inflectional, following below:⁸ Do not change meaning or part of speech, e.g., big, bigg-er, bigg-est are all adjective, and Are suffixes only (in English).
