#### **CHAPTER 1**

### A. Background of Study

Language is one of important things for everyone in this life. Language is used to communicate with others, share stories, knowledges, experiences, etc. Language as the system of human communication are usually not spoken in exactly the same way a language is spoken by different people are described in terms of regional and social variation (dialect, sociolect).<sup>1</sup> Someone starts using language from birth, babies use cry which is a sign language when they need something.
