#### CHAPTER 1

### INTRODUCTION

# A. Background of the Study

Communication is a process of transferring information, messages, and a conversation by one person to another. The information or message comes with the intention of someone who conveys information. In an act of communication there is usually at least one speaker or sender, a communication message which is transmitted, and a person or persons for whom this message is intended<sup>1</sup>. Speech act is speech accompanied by action, when someone speak not only issue speech but also does an action. Every people are produced most of speech acts in everyday life, but they not aware about it because they lack of knowledge about the speech acts. Therefore studying speech act is very important for us because every day we communicate and say something. Someone produce an action in every utterance of doing an action. The action divide into three part there are locutionary act, illocutionary act, and perlocutionary act. Locutionary act is speech that can influence the listener to do something. In the act of locutionary there is a hidden meaning in the utterance by the speaker, for example someone says "it's very hot here" in this case the utterance may perform an act of requesting the listener to do something in relation to the hot place, such ac turning on the fan or air condition. While. illocutionary act is the act of issuing a speech with a certain force. For example when someone " promise to do something, the utterances strength that the speaker will to do something in the future. And the last is perlocutionary act, perlocutionary act is the act of influencing the listener to do something that has an effect on the listener. For example a teacher ask the student "where is your shoes?" the student will look at his feet and say that his shoes are out of class.

In this paper, the researcher analyze A Turtle Tale Sammy's Adventures Movie Script, because in this film the researcher seen many speech act used by the player in Turtle Tale Sammy's Adventures Movie, especially the main character in the movie. The speech acts which are widely used in A Turtle Tale Sammy's Adventures Movie Script an illocutionary act, illocutionary act is divided into five basic kind of action, each of which has various kind of strength in influencing the listener. The five basic kind of illocutionary are representatives, directives, commissives, expressives, and declaration. Besides, many speech act used by the main character in A Turtle Tale Sammy's Adventures Movie Script, there are also moral value that we can take and applied in real life. This film does not show vulgar scenes, so it is great to watch for young children, especially in the current situation, when people are encouraged to stay at home for doing something.
