CHAPTER I

INTRODUCTION

A. Research Background

English is an international language is needed by all levels of education to be mastered. This research also take a place in bilingual schools setting and use qualitative method. Here, the researcher also finds the difference in this research. Like, this research just talk about the benefit of bilingualism in early childhood without explain about how young learners acquire the language and develop the language. Then, participant from this research is students. Second is written by Djoko Sutopo on journal of education and practice Vol. 4 No. 26 (2013) with the title "The Interlanguage of Indonesian Young Learner of English: A Case Study on an Indonesian Bilingual School Kindergarten Student's English Speaking Acquisition" this study is interested in learning perspective, meaning that it aims at describing the process attempted learning of a second language. In order to describe the process this study needs data in the form of behavioral events or observable data to which we can relate theoretical predictions such as utterances which are produced when the learner attempts to say sentences of the target language. This study also

show the dialogue between child, her mother, and her grandfather are inherently interactive in the sense that they typically do not involve simply one move from one speaker. The social role of the mother and the grandfather gives access to the full range of initiating speech functions when interacting with child, while the social role of the child places constraints on both the frequency and types of initiations that can be made to the parents and to the child. In addition the children can speak two language that related in their environment and their parent can help them to speak English in their daily activities, not only in the schools.

Based on the research above, the researcher finds the similarity with their research, such as this research discuss and analysis about how young learners improve their language in daily activities and take a place in bilingual schools setting. This research also use case study in qualitative method. But, the difference from this research are this research describe how young learners can speak two language and the instrument from this research is observe the learner's interlanguage and focused to family who speak English to young learners to improve their language. While her research focused on the processing of English teaching when learning process, how young learners feel enjoy and comfortable in the class to learn English and how the interaction between young learners and teacher in the class. Her research also take a place in primary school and focused to the teacher and students.

B. Focus of the study

Based on the background of the study above, the researcher intends to explore the area of teacher's performance in the classroom which is pressured on teaching English for young learners especially in teaching and learning process in the classroom. The researcher limits the research area only two aspects are about teacher activities and the media used in teaching English for young learners' classroom. Therefore, this research does not focus on all aspects of the process in English teaching and learning, instead it only focuses on teacher activities and the media used in teaching.
