

CHAPTER V

CONCLUSION, IMPLICATION AND RECOMMENDATION

A. Conclusion

Based on the findings, the results of the research can be concluded as follows.

1. Kinds of Maxim Violation done by the actor in the movie entitled “Frozen II”.

This study was concerned with the use of maxim violation based on Grice’s theory of Cooperative Principle in the movie entitled “Frozen II”. There are four kinds of maxim violation done by the actor in Frozen II movie. The writer found 18 utterances which had violated the maxim. Violation of Quantity Maxim is the highest occurrences used by the actor among other kinds of maxim violation. It was found 10 times (55%) total data. It is followed by Violation of Quality Maxim is 3 times (17%), Violation of Manner Maxim is 3 times (17%) and Violation of Relevant Maxim is 2 times (11%).

2. Kinds of Politeness Achievement based on Leech’s Theory of Politeness Principle in the movie entitled “Frozen II”.

This study, not only discuss about Maxim Violation, but also Politeness Achievement. There are six kinds of politeness Principle done by the actor in Frozen II movie. Among them, the writer found 21

utterances which had achieved politeness in total due to the occurrence of 3 double. However, the analysis is done by analyzing each politeness strategy separately. Tact Maxim is the highest occurrences used by the actor among other kind of politeness achievement. It was found 10 times (47%) total data. It is followed by Generosity Maxim is 3 times (14%), Approbation Maxim is 3 times (14%), Modesty Maxim is 2 times (10%), Agreement Maxim is 2 times (10%) and Sympathy Maxim is 1 time (5%).

B. Implication and Recommendation

This study focuses on the usage of maxim violation and politeness principle in the communication of the actor in the movie entitled “Frozen II”. This study contributes on the improvement of understanding language studies especially on maxim violation of cooperative principle and politeness achievement of politeness principle. It will become a direct contribution to the existing knowledge in the linguistics field especially on pragmatic. This study can also make easier the next writer who conducts the same field of research as the reference or comparison that might be relevant to the researched subject. Meanwhile this study also contributes to education in Indonesia to be more polite when conversation with other, as we know that Indonesia is located in eastern and eastern is famous with politeness than western. So, Indonesian people have to more polite than western.

Based on the conclusions and the implication, some recommendations are proposed to the following parties:

1. To linguistics students

The students should be open minded that maxim violation of cooperative principle and politeness achievement of politeness principle is very important part in linguistics especially on pragmatics. Moreover, study about maxim violation of cooperative principle and politeness achievement of politeness principle that usually used in movie, interaction of communication, lyrics of song, newspaper, novel, etc. Using them should be help the learner in language skills. It will be gives the knowledge about how the way to communicate correctly between the speaker and the interlocutor.

2. To other writer

This research still has many weaknesses. It is still limited on maxim violation and politeness principle between the speaker and the interlocutor. On the other hand, there are different other kinds of interaction in communication. Therefore, the writer hopes that there are the next writers will be complete this research completely with the similar study
