CHAPTER I

INTRODUCTION

A. Background of the study

Language is very important of the communication and language is system for the expression of meaning: primary function and communication. And so the language is the systems of human language that are used and understood by a particular group of people. English is one of the most urgent languages used by many people in all over the world and social life such as in economy, tourism, technology, and politic fields. In learning English, four skills should be mastered by the students those are listening, reading, speaking, and writing. One of the skills that students should be mastered is writing. Students are expected to write their ideas and communicate their language using words. Because writing is the mental work of inventing ideas, thinking of how to express ideas, and organizing them into statements and paragraphs until it is clearer to the reader.

When the students learn about English text, they are only given the text based on the text provided in the book. Then, they are asked to analyze and comprehend the text itself. However, in the authentic material, the teacher will give the texts without exercise book. Learners feel that they are learning a target language that it is used outside of the classroom.

In this study, the researcher purposes "authentic materials" by using cookbooks as an alternative media to teach writing procedure text. It is based on the belief that authentic materials will help the teacher to reduce the boredom of students, enhance the students' motivation in writing and also help students to develop their ideas and the content of writing. "Texts need not be 'grammatically sequenced' they need only to capture student attention and be comprehensible."

Authentic material in this study is used as a medium of learning outside the textbooks, it means that the material obtained from real life. Source such as magazines, articles, cookbooks, photos, news, and others.

Ary, Jacobs, dan Razafieh states:

A fundamental assumption made by scientists is that the events they investigate are lawful or ordered no event is capricious. This assumption underlies any statement that declares that under specific conditions certain events will occur. Related to this first assumption is the belief that the events in nature are orderly and regular and that this order and regularity of nature can be discovered through the scientific method. A second assumption is that reliable knowledge can ultimately derive only from direct and objective observation.⁵

Based on the statements above, many possibilities can happen in a study, and the possibility that the positive comes from self-confidence. Therefore, researchers can provide two assumptions, the following:

- a. Researcher assumed that by using authentic materials to teach students to be more interested in writing English text well.
- b. Researcher assumed that to attract student interest is to make them feel comfortable and fun in learning, especially by knowing the real life which is included in the authentic material.
